

**ESCALANTE CITY  
ORDINANCE 2024-15**

**AN ORDINANCE AMENDING ESCALANTE CITY CODE NO. 10.36.020, 10.38.020,  
10.40.020 AND 10.42.020 ADDING TWO-FAMILY DWELLINGS TO PERMITTED USE  
AND PROVIDING REPEALER WITHIN THE CITY OF ESCALANTE, STATE OF  
UTAH.**

**WHEREAS**, the City Council, as the governing body of the City of Escalante, State of Utah, specifically finds that it is in the best interest of the safety and welfare of the citizens of the City of Escalante to amend the following Ordinance; and

**WHEREAS**, The City Council and Mayor wish to amend such an Ordinance.

**NOW THEREFORE**, be it ordained by the Council of the Escalante City, in the State of Utah, as follows:

**SECTION 1:**            **AMENDMENT** “10.36.020 Permitted Uses” of the Escalante Zoning Code is hereby *amended* as follows:

- A. Agriculture
  1. Tilling of the soil, the raising of crops, horticulture, and gardening.
  2. Animals, including fowl, for recreation or for family food production for the primary use of persons residing on the premises or for commercial production and sale.
- B. Single-family dwellings.
- C. Two-family dwellings.
- D. Household pets.
- E. Stabling livestock.
- F. Accessory buildings and uses.
- G. Vacation Rentals
- H. Accessory Dwelling Unit
- I. Churches.
- J. Schools.
- K. Parks & Public Buildings.
- L. Public Utilities.
- M. Public Riding Stables.
- N. Public Kennels.
- O. Living Quarters for hired hands, seasonal laborers, or other receiving compensation for work performed on site.
- P. Home Occupation (conditions may apply).

**SECTION 2:**        **AMENDMENT** “10.38.020 Permitted Uses” of the Escalante Zoning Code is hereby *amended* as follows:

10.38.020 Permitted Uses

- A. Agriculture.
  - 1. Tilling of the soil, the raising of crops, horticulture, and gardening.
  - 2. Animals and fowl for recreation or for family food production for the primary use of persons residing on the premises.
- B. Single-family dwellings.
- C. Two-family dwellings.
- D. Mobile Homes.
- E. Private stables, corrals, chicken coops or pens.
- F. Accessory uses and buildings customarily incidental to the permitted use.
- G. Planned Unit Development.
- H. Vacation rentals
- I. Accessory Dwelling Unit
- J. Nursery or greenhouse, excluding any building or structure for retail business separate from the greenhouse growing facility.
- K. Home Occupation (conditions may apply).
- L. Public utilities.


